The allocated funds were carried over to this year. Two insurance payments and two donation payments will thus be made this year.
- b. A new expense line item for \$150 is for database management.
- c. A new income item of about \$800 will come from members who will now pay \$10 annually, if they wish to have their monthly schedule sent to them by regular mail.
