Audit Report

Subject: Indianapolis Hiking Club Audit for 10/1/15 - 9/30/16

Last month I met with Marti Burton and Olga Hackenberg to complete the Indianapolis Hiking Audit for the 2015-2016 fiscal year. This work consisted of matching expenses approved at each board meeting (as shown in the board minutes) to an actual receipt from a vendor. Because of difficulty scheduling a meeting for the three of us together, I met separately with Marti and Olga and went through the same procedure of reviewing expenses with each of them.

In addition to the meetings with Marti and Olga, I matched Kathy Whalen's handwritten accounting sheets, which are an itemized list of monies received and spent, to the following documents:

1. The financial statements presented at each board meeting.
2. Deposits and expenditures shown in the Club's monthly bank statements from Fifth Third Bank.

Marti, Olga, and I were able to reconcile all of the items noted above without any discrepancies. We believe that, as a result of our work, the monthly financial statements presented at the board meetings accurately represent the financial condition of the Club. However, it must be noted that our audit may not be consistent with that done by a professional accounting firm.

I want to thank Kathy Whalen for providing everything needed to complete the audit. The documents she gave me had enough detail to allow us to reconcile all income and expenses.

I want to also thank Marty and Olga for their assistance in completing this audit. During my meetings with each of them, they searched through Kathy's records to find the necessary items when I asked for a different document to match what was shown in the board minutes and financial statements. Thanks to their efficiency, and the organization of Kathy's records, each meeting took less than an hour.
